- Be willing to accept the duties of Honorary Mayor if you win (attend monthly luncheons, monthly mixers, ribbon cuttings, and attend events such as Best of Fair Oaks, Fair Oaks Fiesta, Taste of Fair Oaks, Concerts in the Park, Christmas in the Village and any other event that is requested of you.
